MALSCCE Proprietors' Council membership benefits include:

In addition to paying the current year's MALSCCE dues, Proprietors' Council members pay annual Proprietors' Council dues, which help MALSCCE provide an expanding array of member benefits. Since larger firms have demonstrated a willingness to offer MALSCCE increased financial support, the MALSCCE Proprietors' Council employs a three-tiered dues structure based on the number of land surveying and geospatial employees. Firms with five or less employees of this type will pay \$100; those with six to 15 will pay \$250; and those with 16 or more will pay \$500. This dues payment entitles your company to membership in the Proprietors' Council through June 30, 2019.
