# MassDOT Schedules Capital Conversations, Regional Mtngs to Support Development of 5Year CIP

The sixteen meetings will be held throughout the Commonwealth beginning on Monday, Oct. 19, and continuing through Thursday, Nov. 5, 2015.

## Lyme Disease Legislation - Lobby Day and Hearing at State House - 10/20

MALSCE is supporting two bills related to Lyme Disease that have been filed in the Massachusetts Legislature. We are working with the Massachusetts Lyme Legislative Task Force to support two Lyme insurance bills, H. 901 and S. 502, "An Act Relative to Lyme Disease Treatment Coverage."

These two bills will have their public hearing on Tuesday, October 20 at 11:00 am in the Gardner Auditorium at the State House. MALSCE Member (and Past President) David Humphrey, PLS will testify in support of these bills and we are seeking other members to also support, on October 20 and at other times. The Massachusetts Lyme Legislative Task Force is organizing a Lobby Day in support of S. 502 and H. 901. The Lobby Day will be held on October 20, the same day as the hearing, to maximize grassroots participation from MALSCE and others at the State House.
