1. Chairman Paul Tyrell opened the meeting at 9:07AM and notified attendees of the evacuation procedures.
2. The Board reviewed the minutes of the January 25, 2018 Open Meeting. Ron Willey moved, seconded by Dennis Drumm, to accept the meeting minutes. Azu Etoniru abstained from the vote. Motion passed with a vote of 7-0.
3. Chairman Paul Tyrell recognized PE Exam Applicant David Petersile was in attendance and requested that he address the Board regarding his concerns following his oral interview on February 6, 2018. David Petersile also provided the Board a letter, which the Board accepted. David Petersile briefed the Board on his concerns which he also detailed in a letter that was provided to the Board members. After brief discussion with the Board, David Petersile requested that the recommendation from the Interview Committee regarding his application be table and that he be allowed to either withdraw his application or provide additional documentation of his work experience for consideration. The Board granted his request.
4. Chairman Paul Tyrell recognized PE Exam Applicant Mary Arntzen was in attendance and requested that she present her case to the Board as to why should reconsider their initial assessment that her PE exam application did not meet the requirements for approval. Mary Arntzen briefed the Board about her work experience, in particular, her work with Chicago Bridge & Iron (CBI) and how, in her opinion, her work experience at CBI was the practice of engineering as defined in 250 CMR 3.05 (2).



Chairman Paul Tyrell explained to Mary Arntzen that her work at CBI consisted of field work, Quality Assurance/Quality Control (QAQC), and concrete testing (ACI) which is not considered the practice of engineering under 250 CMR 3.05 (10) and (11). The Board recommended that Mary Arntzen withdraw her application until such time that she has obtained at least one (1) more year of engineering experience at which time she should request that her application be re-opened for examination by the Board.

5. Chairman Paul Tyrell gave the Board a report on the six interviews that were conducted by the Engineering Interview Committee:

7. Clinton Dick informed the Board that no update was available regarding Continuing Professional Competency (CPC).
 8. Clinton Dick reminded the Board about the upcoming 2018 NCEES Northeast Zone Meeting would be held May 17-19 in Portland, Maine. Clinton Dick stated that Paul Tyrell and Ron Willey would be attending as funded delegates and that Joyce Hastings, Azu Etoniru and Joanne Linowes would also be attending.
 9. Clinton Dick informed the Board that no update was available regarding Use of the Title Engineer.
 10. Clinton Dick stated that the Board received a Self-Report of discipline from Licensee #32941-ST. The Licensee had certified to the OK Licensing Board at the time of license renewal that he had completed the required Professional Development Hours (PDHs) when he had not. The Licensee provided the required PDH documentation to the OK Licensing Board and no further action was taken. Clinton Dick informed the Board that the Licensee had properly reported such discipline to MA.

The Board determined that they will take no action against Licensee.


Clinton Dick stated that the Board received a Self-Report of discipline from Licensee #50453-ST. The Licensee was reporting action taken against his license by the OK
