# MALSCE Reaches Three-Year Membership High

We are pleased to report that as we near the end of the fiscal year, MALSCE has a total of 426 members. This is the second year in a row that MALSCE membership has steadily increased. A breakdown of these 426 members by type is as follows:

251 Registered118 Associate25 Out-of-State18 Life7 Honorary7 Sustaining

It's worthy of note that that life membership increased by two this year with the addition of Mary Ellen Streeter and John A. Hammer. Also in the past year, 34 members opted to renew or join the MALSCE Proprietors' Council. Of the registered and associate members, 289 took advantage of the NSPS joint membership program and renewed their National dues through MALSCE.

# Calibration Baseline Survey Results

Prepare boundary, topographic, asbuilt and other land plans, suitable for Town filing, assist in preparation of metes and bounds descriptions, perform record research and Survey calculations; assists on a field survey crew as necessary. Assists with the oversight of vendor work, including developing scope of services, QA/QC and assuring work is performed on-time and within budget. Liaison with engineering and surveying public; respond to right-ofway dimension and real estate questions. The four percent of MALSCE members who responded to this survey indicated that many surveyors that regularly use CBLs have concerns with their local baseline. Traffic, safety, and accessibility seem particularly problematic, especially at baselines on major highways. In other places, accuracy is a concern.

70.6% of respondents indicated that they believe it would be beneficial to establish a CBL in Sturbridge, MA. Other respondents would like their concerns for accuracy addressed at other baselines, such as the one in Norfolk County.

#### Continuing Professional Competency Committee

The next meeting of the MA Board of Registration of PEs and PLSs Continuing Professional Competency Committee is expected to be on June 14, 2016 at 8:30 AM. An agenda is expected to be posted on June 9 on the **Board of Registration's website**.

#### Zoning Reform Debate:

On June 9, 2016, the Massachusetts Senate is schedule to begin debate on <u>S2144</u>: An Act promoting the planning and development of sustainable communities. This is a comprehensive zoning reform bill. Senators have filed 63 amendments ahead of Thursday's debate on the bill, which attempts to rein in restrictive local zoning regulations and incentivize communities to plan for sustainable growth.

Additionally, the Ways and Means Committee has offered a re-drafted version of the bill <u>S2311</u> as an amendment. The Massachusetts Municipal Association is expressing serious reservations with the bill, including provisions that would mandate approval "by-right" of accessory apartments, highdensity residential developments with an open space preservation component and multi-family housing districts. Meanwhile, the Massachusetts Smart Growth Alliance is working in coalition with the Massachusetts Association of Planning Directors, the Massachusetts Municipal Lawyers Association and others to support the bill. It is not clear that the House of Representative plans to take the issue up before formal legislative sessions end next month.
