### Announces Phase 1 of Reopening Has Begun

Governor Charlie Baker announced that phase 1 began as of Monday, which means manufacturing and construction sites are allowed to reopen if they meet the guidelines. Places of worship are allowed to reopen if they follow the guidelines set for them. Around the state, offices spaces can reopen on May 25 if they meet health guidelines, and office spaces in Boston can start June 1. One of the new requirements is that office space can only reopen with 25% capacity. During phase 1, emergency childcare will be expanded for families that have no other option.

The "stay at home" advisory has been changed to a "safer at home" advisory, which the Governor urged residents to still stay at home unless they absolutely need to go out. Limit on gatherings still remains at 10 people.
