On March 23, 2020, Governor Baker issued an emergency order requiring all businesses and organizations that do not provide "COVID-19 Essential Services" to close their physical workplaces and facilities to workers, customers and the public as of Tuesday, March 24th at noon until Tuesday, April 7th at noon. # Baker Administration Issues New Construction Guidance to Municipalities Clarifying Construction as an Essential Service

On March 25, 2020, the Baker Administration issued construction guidance to Massachusetts municipalities overturning all local construction moratoriums. The <u>issued guidance</u> clarified that the March 23, 2020 Order <u>"Assuring Continued Operation of Essential Services in the Commonwealth, Closing Certain Workplaces, and Prohibiting Gatherings of More than 10 People" supersedes and makes inoperative any order or rule issued by a municipality that will or might in any way impede or interfere with the achievement of the objectives of this order. "Construction Workers who support the construction, operation, inspection and maintenance of construction sites and construction projects" are deemed essential.</u>

## Construction Guidelines and Procedures

The Commonwealth of Massachusetts has issued COVID-19 Guidelines and Procedures for All Construction Sites and Workers at All Public Work. These guidelines and procedures, which take effect immediately, were developed in collaboration with state awarding entities so that a consistent document is being implemented and followed across the state.

## FEMA Adds New Elevation Certificate

The Elevation Certificate (EC) is an administrative tool used by the National Flood Insurance Program (NFIP) to provide elevation information necessary to ensure compliance with community floodplain management ordinances; to determine the proper insurance premium rate; and/or support a request for a Letter of Map Amendment (LOMA) to remove a building from the Special Flood Hazard Area. On February 21st FEMA posted a new version of the EC. This form and its instructions and now posted on the **FEMA website**.

The 2020 Earle J. Fennell Award is now accepting nominations. Persons who have worked in any aspect of surveying and mapping education may be nominated. The nominee may or may not be a professional educator but should have a sustained record of superior performance in surveying and mapping education for more than ten years at the local, state, or national level.

The 2020 Student Project of the Year is now accepting submissions. Any undergraduate student enrolled in a surveying or surveying related program (e.g., geospatial sciences, civil engineering, forestry, etc.) is eligible for this award.

This award is open to anyone who has made an outstanding contribution, or has performed outstanding service to the surveying profession. It is not necessary for a candidate to be a surveyor (e.g., an attorney, educator, cartographer, historian, or politician may be nominated for their contribution).
