About the poll

These results are based on a survey of 1,401 Massachusetts residents, including 967 who live in communities served by the state's 15 Regional Transit Authorities (RTAs). Responses were collected via online survey, text messages, and live interviews via landline and cells phones between February 23 and March 7, 2023. The data were weighted to reflect known and estimated population parameters for residents with and without RTA service. Groups were then combined and weighted to the population parameters by race, age and gender, education, geography, and political identification for the state as a whole. The credibility interval for this survey is +/- 3.1 percentage points for the entire sample, including the design effect. This project was conducted by The MassINC Polling Group in collaboration with the Regional Transportation Authority Advocates Coalition (RTAAC) and sponsored by The Barr Foundation.
