CONSENT AGREEMENT

The Massachusetts Board of Registration of Professional Engineers and Land Surveyors and Michael Burke ("Respondent"), do hereby stipulate and agree that the following information shall be entered into and become a permanent part of the Respondent's record maintained by the Board:

- The Respondent agrees that this Consent Agreement ("Agreement") is entered into in resolution of the Board's investigation of complaint Docket No. 2021-000319-IT-ENF and the Order to Show Cause issued pursuant thereto.
- The Respondent acknowledges and admits that if the present matter proceeded to a hearing before the Board, it could find that in 2021 he stamped plans for a project located at [REDACTED] which contained structural deficiencies, subjecting him to sanction pursuant to G.L. c. 112 s. 61.
- Whereby, in an effort to resolve this matter without the need for a formal hearing before the Board, the Respondent agrees that his license shall be SUSPENDED for a period of six (6) months. At the end of said six (6)-month period, it is the Respondent's responsibility to contact the Board in writing in order to have his license removed from suspension status. Said action shall be automatic so long as no valid and substantiated complaints have been filed against Respondent, based on conduct of Respondent alleged to have occurred during such six (6)-month period. If such action is denied, the reasons for such denial shall be provided to Licensee in writing and subject to M.G.L. c. 30A judicial review.
- The Respondent further agrees to pay a FINE in the amount of two hundred dollars (\$200.00). Said amount shall be in the form of a check or money order payable to the Commonwealth of Massachusetts, and shall be delivered with a signed copy of this Consent Agreement to Prosecuting Counsel Seth Henderson, Office of Prosecutions, Division of Occupational Licensure, 1000 Washington Street, Suite 710, Boston, Massachusetts 02118.

5. The Respondent agrees to comply with all requirements contained in this Consent Agreement, all state and federal laws, and all laws and regulations governing the engineering and land surveying professions in the Commonwealth.
6. The Board agrees that in return for the Respondent's execution of this Agreement, it will not further prosecute the allegations arising from its investigation of complaint Docket No. 2022-000971-IT-ENF and the Order to Show Cause issued pursuant thereto.
7. The Respondent understands and agrees that entering into this Agreement is a final act, which is not subject to reconsideration, appeal, or judicial review.
8. The Respondent states that he has used legal counsel in connection with his decision to enter into this Agreement or, if he has not used legal counsel, that the decision not to do so has been one taken of his own free will.
9. The Respondent understands that this Agreement is a matter of public record and the Board may forward a copy of this Agreement to any interested party or agency including the equivalent licensing boards of other states.
10. The Respondent certifies that he has read this document entitled "Consent Agreement." He understands that he has a right to formal adjudication concerning the allegations against him and that during said adjudication he would possess the right to confront and cross-examine witnesses, to call witnesses, to present evidence, to testify on his own behalf, to contest the allegations, to present oral argument, to appeal to the courts, and all other rights as set forth in the Massachusetts Administrative Procedures Act, G. L. c. 30A, and the Standard Adjudicatory Rules of Practice and Procedure, 801 CMR 1.01 *et seq.* The Respondent further agrees that he understands that in executing this document entitled "Consent Agreement," he is knowingly and voluntarily waiving his right to a formal adjudication of the above-referenced complaint and to all of the related rights listed above.
11. The Respondent understands that this Agreement will not be effective until the Board formally approves it, and the "Effective Date" of this Agreement shall be the date it is signed by the Board.
