- Demonstrated experience in integrating and managing BIM/VDC in the planning, design and construction. Experience of utilizing Lean Design & Construction (Last Planner System, Scrum or other tools) to increase the reliability and significantly improve projects and teams' performance

- Project understanding and proposed approach including QA/QC process, cost management and scheduling capabilities, construction oversight, ability to plan and perform work with minimal disruption to operations
- Demonstrated experience in sustainable and resilient high performance design & construction, including experience with net zero
- Proposed approach to enhance diversity & inclusion to increase the pool of consultants working on Massport projects.
