MALSCE Proprietors' Council membership benefits include:

- receiving periodic invitations to council meetings where business matters, government affairs and the challenges and opportunities impacting MALSCE as well as the land surveying and civil engineering professions are discussed;

In addition to paying the current year's MALSCE dues, Proprietors' Council members pay annual Proprietors' Council dues, which help MALSCE provide an expanding array of member benefits. Since larger firms have demonstrated a willingness to offer MALSCE increased financial support, the MALSCE Proprietors' Council employs a three-tiered dues structure based on the number of land surveying and geospatial employees. Firms with five or less employees of this type pay \$105; those with six to 15 pay \$265; and those with 16 or more pay \$525. This dues payment entitles your company to membership in the Proprietors' Council through June 30, 2024, as well as the Proprietors' Council membership renewal period which last until the fall of 2024.
