Congressman Richard Neal [Announces Massachusetts to Receive \\$1.1 Billion for Bridges Under Bipartisan Infrastructure Law](#)

At press time on 1/19:

- **Attorney General Maura Healey**, is expected to announce her campaign for governor. She would join other declared Democrat candidates **State Senator Sonia Chang-Díaz** (D-Boston) and **Harvard Professor Danielle Allen**. For the Republicans, the only declared candidate for governor is **former State Rep. Geoff Diehl**.

- Now **former Rep. Claire Cronin** (D-Easton) took her oath of office inside the State House as the new U.S. ambassador to Ireland. ACEC/MA has enjoyed working with Ambassador Cronin on state legislation; we wish her well in her new role.
