Legal Challenges to Federal DBE Program

In September 2024, a federal district court in Kentucky ruled that the raceand gender-based contracting preferences used in the U.S. DOT Disadvantaged Business Enterprise (DBE) program violate the Constitution's guarantee of equal protection under the Fourteenth Amendment. This decision and subsequent November court decision may disrupt longstanding procurement frameworks and force public agencies and the contracting community to significantly modify their approaches.
