MBTA Requests Fiscal Year End Invoices by June 6, 2025.

MBTA Chief Engineer Sam Zhou contacted ACEC/MA last week with the following request:

"In an effort to pay our contractors, consultants and vendors prior to the end of the fiscal year, we are requesting that complete and accurate invoices for contract work through May 31, 2025 be submitted in e-Builder no later than **Friday, June 6, 2025.** This deadline will allow sufficient time for review and processing by the MBTA Project Office, Finance Department and Accounts-Payable prior to the final pay cycle of the fiscal year. **In addition, all parties are reminded that every effort should be made to convert ETSAs to Task Orders/Amendments and Work Directives to Change Orders/Risk Reallocations as soon as possible to allow for invoicing prior to the end of the fiscal year.**"


