

USACE Task Order Memo Released: Updated Procedures for the Selection of Task Orders on A/E Indefinite Delivery Contracts (IDCs).

ACEC National's Dan Hilton shared this with ACEC/MA: The Army Corps of Engineers recently published a Memorandum for the Acquisition Community: <u>Updated</u> <u>Procedures for the Selection of Task Orders on</u> <u>Architect-Engineer Indefinite Delivery Contracts (IDCs).</u> This memo rescinds the Directors Policy Memorandum 2020-02, which was published in March 2020.

The guidance's purpose is to reinforce requirements and specify procedures for the selection of an A/E contractor under a multiple-award task order contract (MATOC). ACEC Federal Agencies and Procurement Advocacy Committee Chair, Miro Kurka, served on the Industry-USACE "Tiger Team" to help the Corps identify a new path forward to develop the guidance. The guidance has been issued to ensure compliance with the Brooks Act and FAR requirements, it can be broken down into five components....<u>More></u>
