MBTA Requests All FY2021 Invoices for work completed from Design Consultants by 6/10/2021

As of May 3, the MBTA has 244 outstanding invoices for design – that they have not received from 30 prime design consultants – for an estimated \$21 Million. The MBTA has asked us to emphasize that they need invoices for FY2021 to be submitted **before June 10** (even earlier is better) to be able to pay them before the end of FY2021. They are really eager to get these submitted so they have time to work on them and get them paid before June 30, 2021.
