



- Project Relevance: Make sure they show relevance with evaluation factors

## **Question 5: Supplemental Response**

- Brochure: This is NOT a place to put boiler plate information about your firm
- Optional: Chart of how team experience fits with project? Unique skills and experience? Table of similar projects?
