In addition to paying the current year's MALSCE dues, Proprietors' Council members pay annual Proprietors' Council dues, which help MALSCE provide an expanding array of member benefits. Knowing that larger firms are willing and able to offer MALSCE increased financial support, for fiscal year 2018 MALSCE Proprietors' Council has adopted a three-tiered dues structure based on the number of land surveying and geospatial employees. Firms with five or less employees of this type will pay \$100; those with six to 15 will pay \$250; and those with 16 or more will pay \$500. This dues payment entitles your company to membership in the Proprietors' Council for a 12-month period beginning on July 1, 2017.
