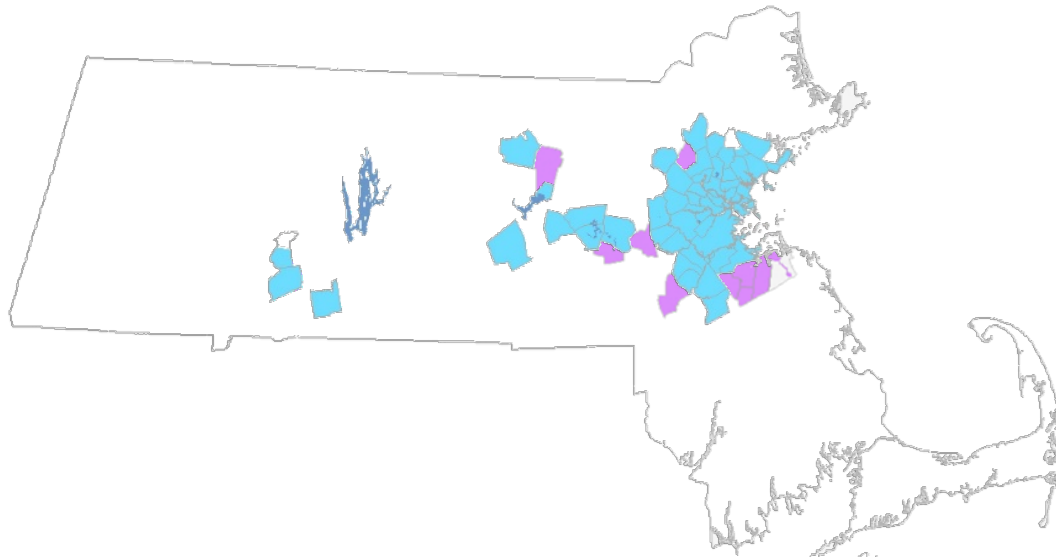

MWRA ...

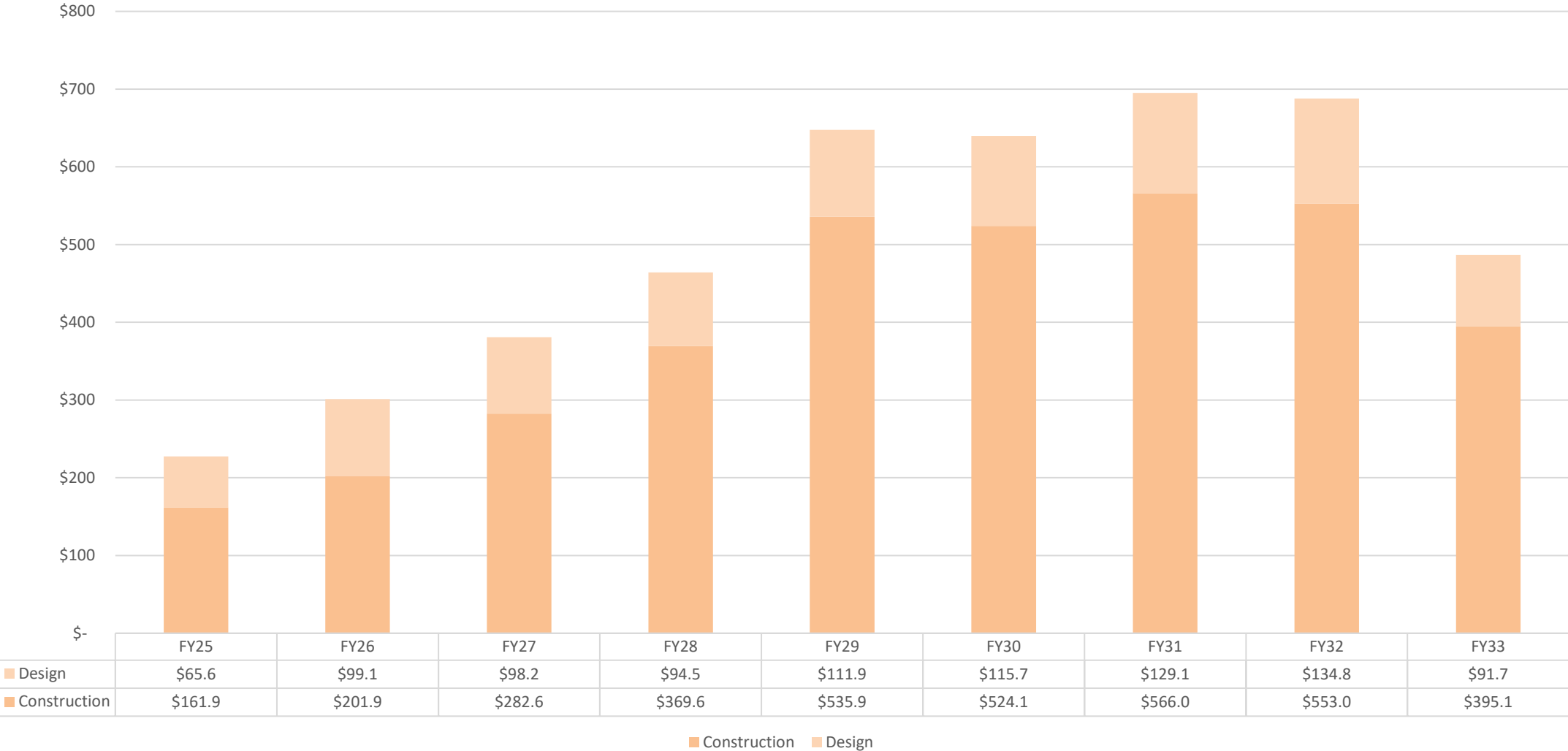
- provides wholesale water and wastewater services to over 3.1 million customers in 61 communities

MWRA Capital Improvement Program - Projected Spending

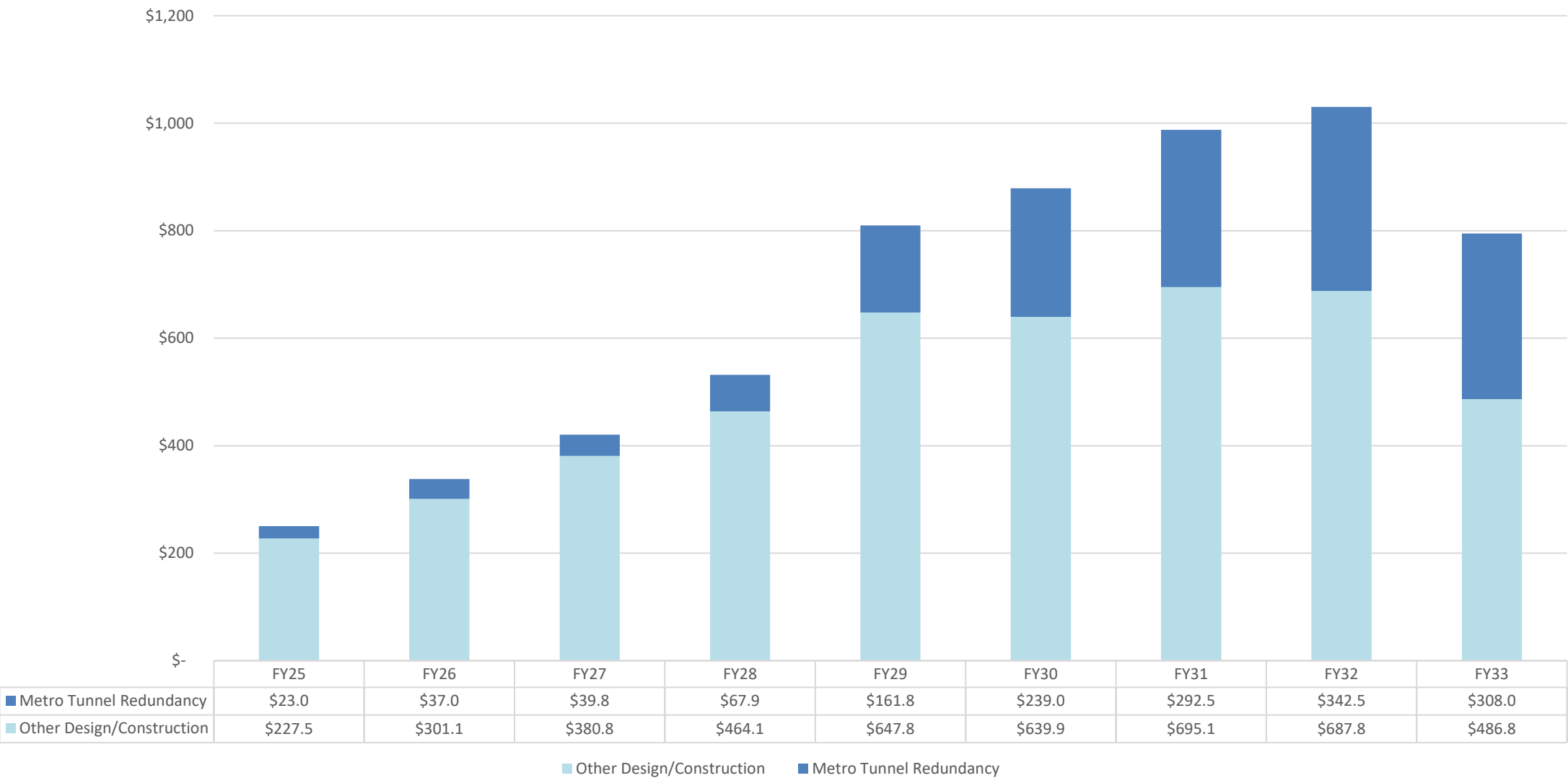
Design vs. Construction (\$s in millions)

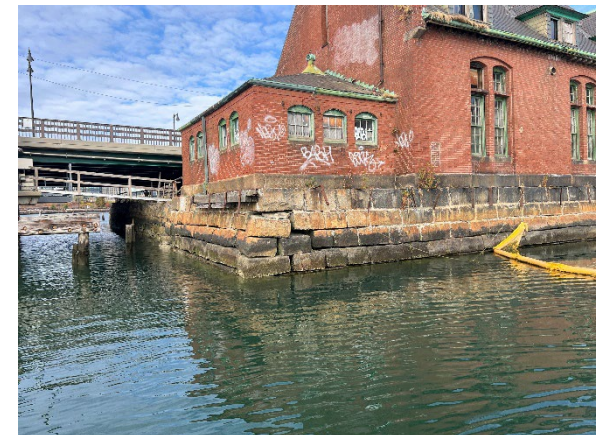

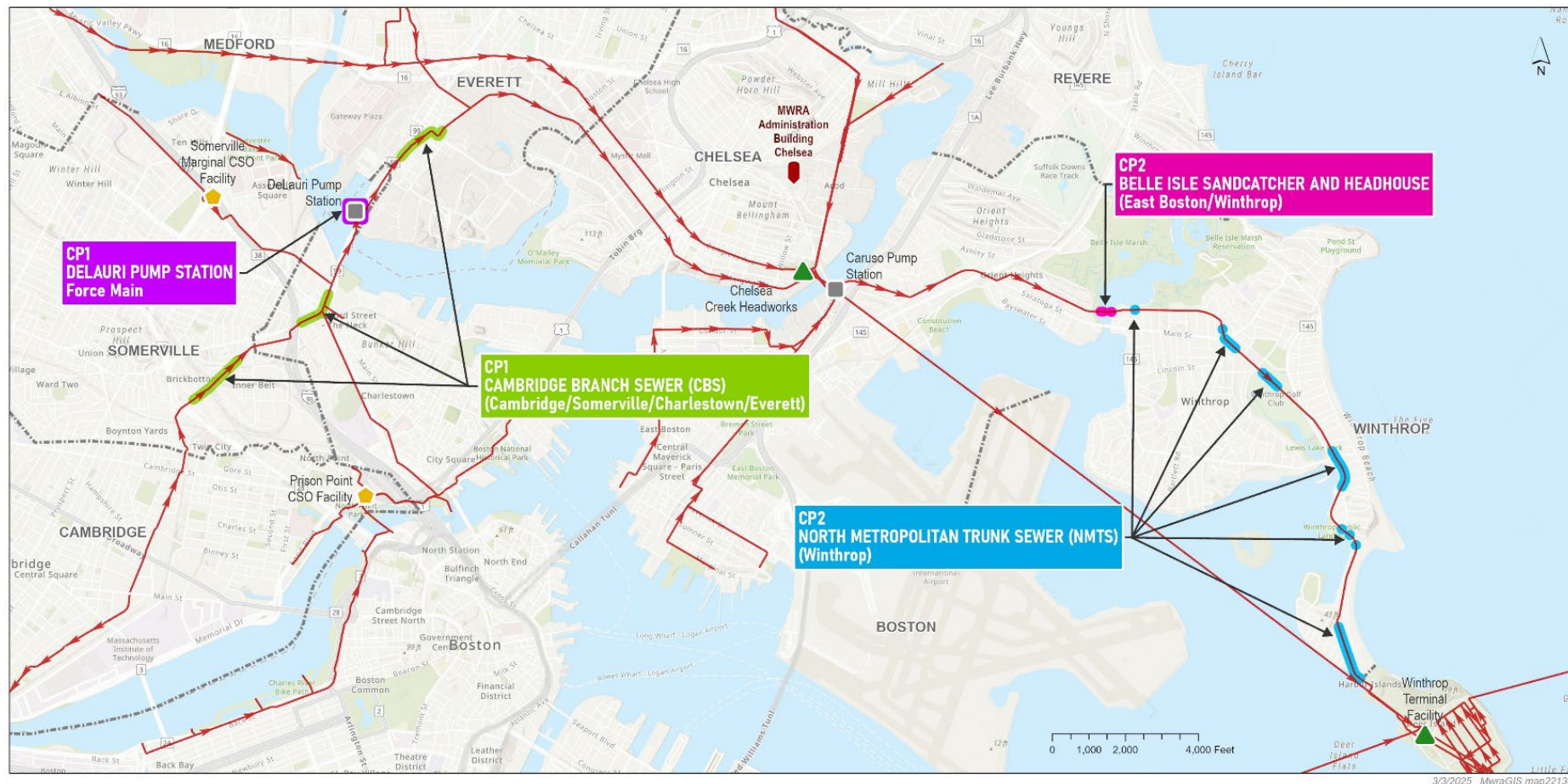

Changes to Design Contracts Packaging

- Packaging design projects into bigger design contracts
- For example, North Collection Sewer System
- Design/ESDC/REI Services
- Estimated Cost \$9.2M
- Advertisement - August 2025





Engineering Professional Services Contracts

- Inclusion of Resident Engineering and Resident Inspection Services in the design contracts
- Evaluating Construction Manager-at-Risk
- Proposal Evaluation
 - Cost – selection not based on price
 - Multiple selection criteria are weighed
 - Cost reasonableness
 - Qualifications and Key Personnel
 - Technical Approach, Capacity/Organization, and Management Approach
 - Relevant Experience/Past Performance
 - Minority and Women-Owned Business Enterprise Participation



Acquiring Consultant Work at the MWRA

- Process
 - Ok to contact PM before the project has been advertised
 - RFQ/P (or RFQ, RFP) Advertisement
 - MWRA Portal
 - Notification of advertised RFQ/Ps sent to registered users

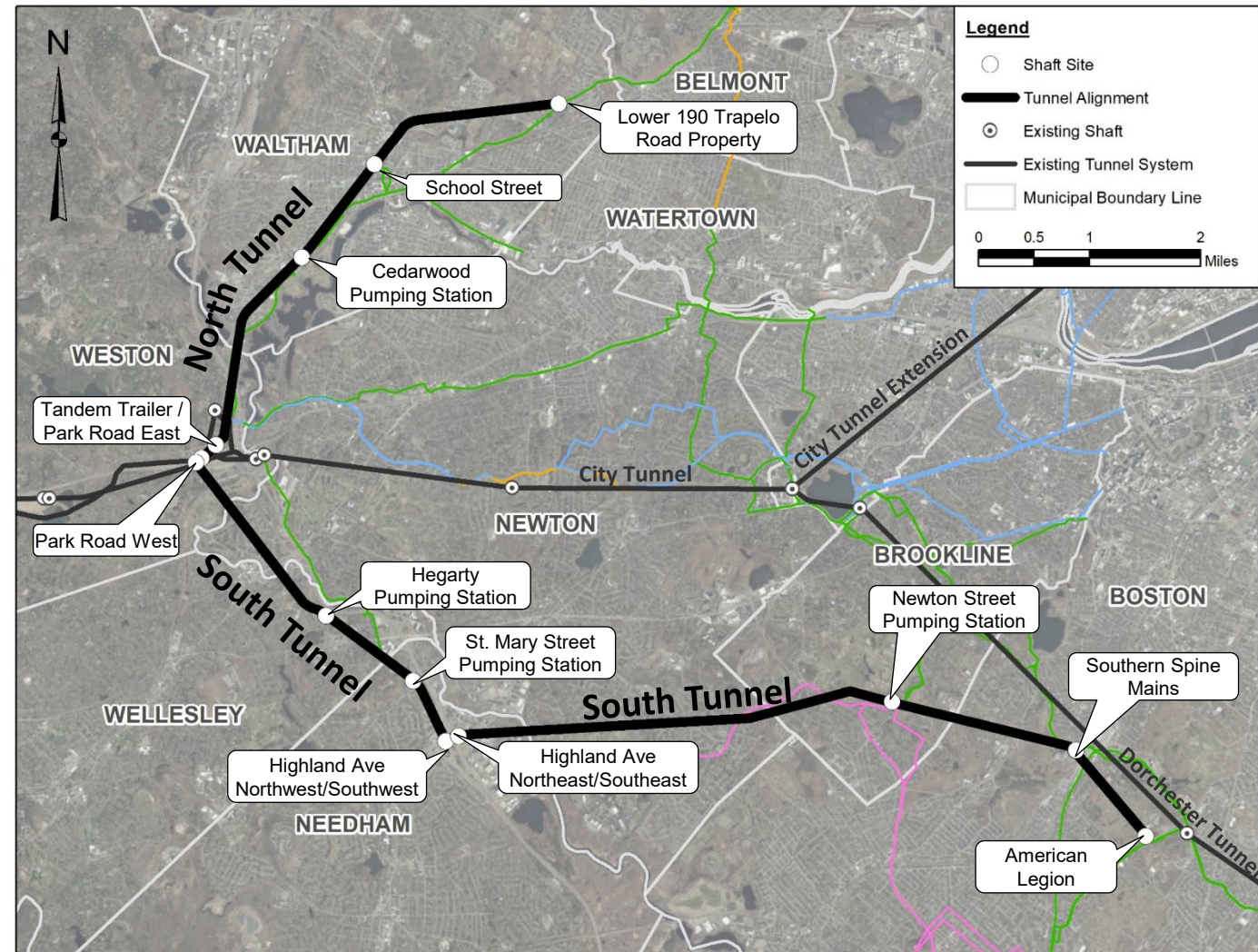

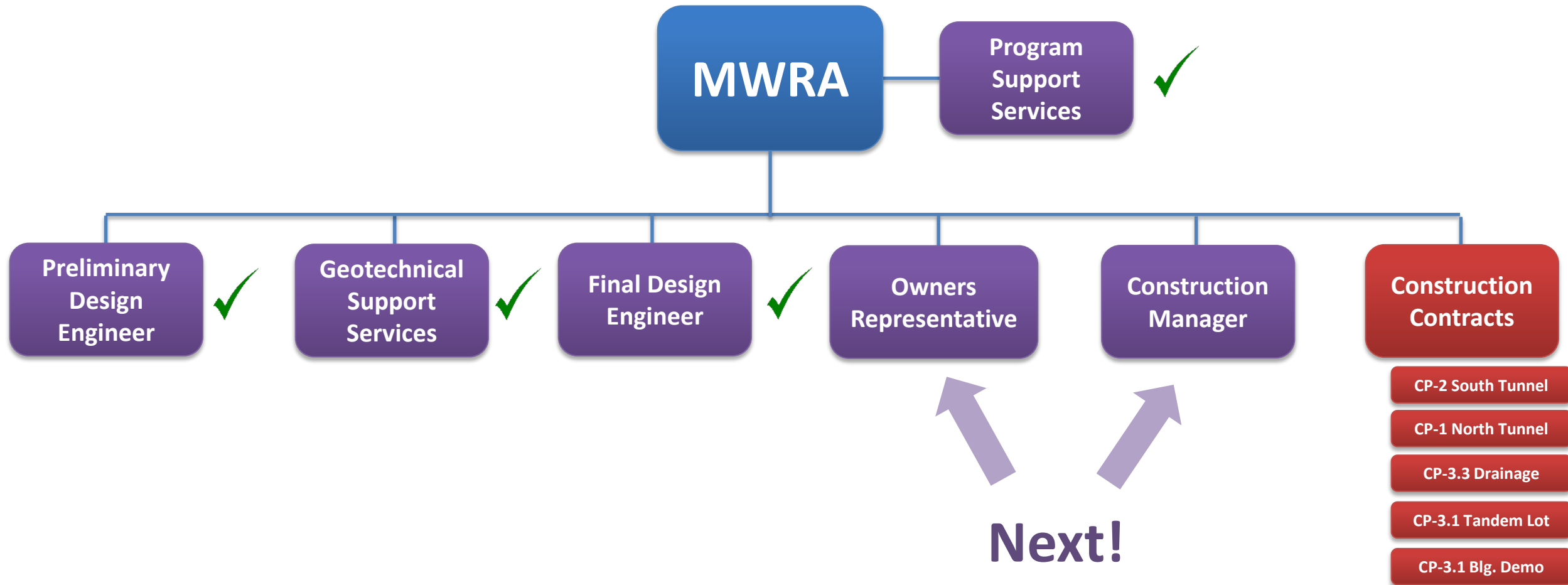
Metropolitan Water Tunnel Program - Overview

- Draft FY26 CIP - \$2.1B
- ~15 miles of deep, hard rock, pressure water tunnels
- 13 Shaft Sites
- Tunnels will begin in Weston (I-90/I-95)
- North Tunnel - ~5 miles, ends in Waltham
- South Tunnel - ~10 miles, ends in Mattapan near American Legion Hwy
- Tunnel Construction anticipated between 2028 and 2040
- Design-Bid-Build

Mass General Law (MGL) Chapter 30, Section 39M1/2

Anticipated Scope of Services:

- Peer review of engineering elements
- Oversight of cost recovery and value engineering
- Filing annual reports

Minimum Qualification:

- Registered Professional Engineer in the Commonwealth of Massachusetts (by time of award)
- Minimum of five (5) years of experience in construction and construction supervision of project of similar nature, scope and complexity
- Independent of the designer, contractor, or subcontractor involved in the Program (including CM)

Draft FY26 CIP:

- \$6.3M
- 2026 - 2040 (aka Program Completion)

Planned Procurement Schedule:

- “cone of silence” begins – Fall 2025
- RFQ/P issued – December 2025
- NTP – May 2026
