## Membership Classification

- Registered Member** of MALSCCE is an individual registered under the laws of the Commonwealth as either a Professional Land Surveyor or as a Professional Engineer. A Registered Member enjoys full voting privileges and is entitled to hold any office in MALSCCE. *Annual Dues are \$250. Chapter Dues are \$20.*
- Associate Member** of MALSCCE is an individual interested in the advancement surveying and mapping who does not otherwise qualify under any other membership classification. An Associate Member enjoys full voting privileges but may not hold the office of a MALSCCE officer. *Annual Dues are \$140. Chapter Dues are \$10.*
- Student Member** of MALSCCE is a student enrolled in a full-time undergraduate degree program of an accredited school, college or university, which is also recognized by the Board, who has a sincere interest in land surveying. A Student Member has no voting privileges and may not hold office in MALSCCE. A Student must submit a current copy of their student I.D. along with this application. *Student membership is free.*
- Out of State Member** of MALSCCE is an individual interested in land surveying, registered or non-registered, who is not residing or practicing land surveying full time within the Commonwealth. An Out of State Member has no voting privileges and may not hold office in MALSCCE. *Annual Dues are \$200.*



**Joint MALSCCE-NSPS 100% Membership Program:** Registered MALSCCE Members who legally reside in Massachusetts are automatically enrolled in this program at an annual dues rate of \$50. MALSCCE Associate Members who are Massachusetts residents and MALSCCE Student Members can opt to participate in this program at the cost of \$50 and \$10, respectively. MALSCCE members who do not reside in the Commonwealth should contact their resident state land surveying association to see if they are now offering this joint membership benefit.
