**CONSENT AGREEMENT**

The Massachusetts Board of Registration of Professional Engineers and Land Surveyors (hereinafter "Board") and William A. Parrott, Jr. ("Respondent"), do hereby stipulate and agree that the following information shall be entered into and become a permanent part of the file of the Licensee, which is maintained by the Board:

1. Respondent agrees that this Consent Agreement ("Agreement") has been entered as a result of the above-referenced complaint in Docket No. 2022-000934-IT-ENF.
2. Respondent has not been licensed by the Board as an engineer at any time.
3. On or about October 5, 2022, the Board filed a complaint against Respondent alleging that Respondent aided and abetted the unlicensed practice in the field of engineering, along with fraud and/or deceit in response to an investigation involving the unauthorized use of the engineering stamp of a formerly-licensed engineer.
4. Respondent acknowledges and admits that his conduct, as described in paragraph 3, is in violation of G.L. c. 112, §§ 65A and 81T and 250 CMR 7.09(1) by having engaging in the unlicensed and unauthorized practice of engineering.
5. Whereby, in an effort to resolve this matter swiftly and amicably, Respondent agrees to pay to the Board a **FINE** in the amount of **one thousand dollars (\$1,000.00)** upon submission of this signed Agreement. Said fine payment shall be submitted in the form of a bank check or money order made payable to the Commonwealth of Massachusetts.
6. The Board agrees that, in return for Respondent executing this Agreement, the Board will not conduct any further prosecution based upon complaint docket number 2022-000943-IT-ENF.

7. Respondent acknowledges and understands that this Agreement is a matter of "public record," and that the Board may forward a copy of this Agreement to any interested party or agency, including the equivalent licensing boards of other states or to any other individual or entity as permitted or required by law.
8. Respondent understands and agrees that the disciplinary action described in this Agreement is a final act, which is not subject to reconsideration, appeal, or judicial review. He hereby waives his right to an administrative hearing relative to this matter. Respondent also waives any right to appeal this administrative action under the provisions of G.L. c. 30A or any other related law.
9. Respondent states that he has used legal counsel in connection with his decision to enter into this Agreement, or if he has not used legal counsel, that such decision was freely made.
10. Respondent certifies that he has read and understood this Agreement and has had the option of discussing it with counsel. Respondent understands that he has a right to a formal adjudicatory hearing concerning the Complaints and that at said hearing he would possess the right to confront and cross-examine witnesses, to call witnesses, to present evidence, to testify on his own behalf, to contest the allegations, to present an oral argument, to appeal to the courts, and all other rights set forth in the State Administrative Procedure Act, G.L. c. 30A, and 801 CMR 1.00 *et. seq.* Respondent further states that he understands that by executing this Consent Agreement he is knowingly and voluntarily waiving his right to a formal hearing and to all of the above-listed rights attendant thereto.
11. Respondent understands that this Agreement will not be effective until the Board formally approves it, and the "Effective Date" of this Agreement shall be the date it is signed by the Board.
