These materials vary from business qualifications, and scopes of work, to technical reports and memoranda, and from field reports to specifications. Each product needs to speak to the intended audience with clarity to minimize legal risk and reduce insurance exposure.

This course goes beyond the basic writing skills necessary for grammatically correct technical reports and marketing documents, and addresses word choice, implied meaning, and assumption of risk. The purpose of this course is to help writers with 5-8 years of work experience gain a better understanding of:

- How to prepare readable documents for various audiences
- The value of quality control and consistency
- Writing as a collaborative process.
- How to develop clear and unambiguous materials
